

Federal Direct PLUS Loan borrowers with an adverse credit history are required to complete PLUS Counseling prior to the first disbursement of loan funds. To complete your counseling:

- 1. Using your FSA ID, log in to <u>StudentLoans.gov</u>.
- 2. On the Welcome to StudentLoans.gov screen, select Complete Counseling.
