1. Your **signed** Social Security Card; **AND**
2. **One** of the three documents listed below.
  - a. Alien Registration Receipt Card with picture, copy both sides. (I-151, I-551, or I-551C with valid expiration date)
  - b. Arrival - Departure Record (I-94) with the INS stamp. (Proof of being processed for an I-551 with valid expiration date) The following statuses are allowed:
    - Refugee
    - Asylum Granted
    - Paroled (must confirm minimum of 1-year and status has not expired)
    - Conditional Entrant (valid only if issued before April 1, 1980)
    - Cuban/Haitian Entrant, status pending
  - c. T-1 visa issued to student's parent
