Required Documentation:

Submit a copy of the official document from your homeless liaison stating your official Unaccompanied Homeless Youth status.

If you do not have Unaccompanied Homeless Youth status, go to fafsa.ed.gov to make the necessary corrections. Refer to the Dependency Status section to correct this error.

2. On or after July 1, 2021, the director of an emergency shelter program funded by the U.S. Department of Housing and Urban Development determined that I was an unaccompanied youth who was homeless.

Required Documentation:

Submit a copy of the document from the director of the emergency shelter stating your official Unaccompanied Homeless Youth status.

If you do not have Unaccompanied Homeless Youth status, per the director of an emergency shelter, go to fafsa.ed.gov to make the necessary corrections. Refer to the Dependency Status section to correct this error.

3. On or after July 1, 2021, the director of a runaway or homeless youth basic center or transitional living program determined that I was an unaccompanied youth who was homeless or was selfsupporting and at risk of being homeless.

Required Documentation:

Submit a copy of the document from the director of the youth basic center shelter stating your official Unaccompanied Homeless Youth status or was self-supporting and at risk of being homeless.

If you do not have Unaccompanied Homeless Youth status or were self-supporting and at risk of being homeless, go to <u>fafsa.ed.gov</u> to make the necessary corrections. Refer to the Dependency Status section to correct this error.
