Health Professions Student Loans are low-interest, need-based federal loans offered to eligible full-time pharmacy & dental students. This loan does not accrue interest until after 12 months after the completion of your program; or termination of full time study. The current interest rate is 5% annually. The award amount is determined by the number of gualified applicants and availability of funds. To be considered for this loan students must:

- Include Parental information on the FAFSA-even if you are married, or your parent(s) live outside of the United States.
- If your parent did not file taxes in 2021, they will need to obtain an IRS letter of Non-Filing at irs.gov. .

Incomplete applications at the time of review will not be considered. Once the review is complete, your FAFSA will be corrected where applicable and notification of eligibility will be sent to your UB email address.
