\_\_\_\_\_ **3.** On or after July 1, 2023, the director of a runaway or homeless youth basic center or transitional living program determined that I was an unaccompanied youth who was homeless or was self-supporting and at risk of being homeless.

**Required Documentation:**  
Submit a copy of the document from the director of the youth basic center shelter stating your official Unaccompanied Homeless Youth status or was self-supporting and at risk of being homeless.
